Message from the President

August 2012

Some hot summer so far ... but our grounds still look amazing! We'll see how our water bills look when we get to the fall. Still, I am always pleased (and proud) when we hear terrific comments from folks who are looking at our community to purchase or to rent ... there have been several glowing accounts. Seeing KVTA property values rise, with recent sales activity, should be a very rewarding situation for our neighborhood.

At the meeting on August 7th the Board approved (unanimously) to 're-establish' ourselves as a truly *covenant controlled community*. While we have always been so historically, we must admit to not always being as diligent in upholding covenants, by-laws, and regulations established when the original homeowners were given full management responsibility by Writer Homes in the late 70's. Times have changed and managing this facility is more complex in 2012. This Board, with assistance from our Architectural Control Committee, will begin the process of more diligently supervising any and all covenants which protect the integrity, consistency, and appearance of our buildings, our grounds, and your KVTA community. We do not intend to go back, however, effective immediately; we expect any and all changes planned for the outside of any townhome be **PRE-APPROVED PRIOR** to any work being done. If a homeowner or tenant decides to make changes without such approval, they should expect to be held financially liable for changes which need to be made for proper compliance.

We will shortly add signs at the entrances to our community, stating "Knolls Village/A Covenant Controlled Community". While we do not intend to become a rigid, overly restrictive, or unreasonable body to deal with, but we do expect anyone currently residing here, or others who intend to become members of this community, to abide by rules and governances as spelled out in closing documents. These are available on our website and provided in the welcome packets personally presented to every new resident within weeks of their moving into The Village.

At this same meeting, your Board approved a plan to increase monthly dues effective January 2013 by ten dollars a month. There is a report from our Treasurer, Joe Johnston, in this newsletter with more information. Monthly dues of \$145, which include water and exterior painting every six years, are still well below any other homeowner associations of our size. At our annual homeowner meeting on October 9, 2012 at the clubhouse, we will review the budget process.

With that all addressed, I would be remiss if I did not also mention a couple of other items:

- Please keep your youngsters off the sidewalks and driveways with bicycles, tricycles, and skateboards
- Consider turning outside lights on at dark, both in front and at the back of your homes -- less crime!
- 3. Think about alignment when parking in open spaces to accommodate as many vehicles as possible
- 4. Watch out for the purple berries on sidewalks at the ends of most buildings -- stains on carpets!

REPORT FROM YOUR TREASURER 8/2012

Over the past 5 years, Knolls Village Townhouse Association has not increased monthly homeowner dues. Overall, our Reserves are very healthy, but that has been due to patching/fixing our infrastructure (roads, sidewalks, landscaping, sprinklers and pool) while deferring major replacement costs. Built in the late 1970's, KVTA is now at a point where fixing is no longer viable. As many are aware, water is the single largest expense our Association pays. Irrigation accounts for a large amount of this expense. Since 2007, water prices have increased by over 40% and we continue to accelerate our expenses in maintaining a sprinkler system which has far out-lived its intended service life. Warren and his team are now spending upwards of 60-70% of their time patching our sprinkler system. KVTA President, Dick Campbell, and the rest of your KVTA Board strongly request your support in the coming months as we recommend an increase in dues by \$10 per month. This not only allows us to address the sprinkler system, but also keeps the driveway/sidewalk and other replacement programs in progress as we continue to modernize the infrastructure of our KVTA community.

ARCHITECTURAL CONTROL COMMITTEE

It's a busy, exciting time in our Village. Roofs, windows, doors are being replaced and sixty-six townhouses received a new coat of paint in the spring. Trees have been trimmed. Alleys are being



refurbished. Our neighborhood is looking good!

Every week I am privileged to talk with the nicest people, residents of Knolls Village who are submitting applications for improvements to their property. This is a rewarding and fun part of our committee.

We have an opportunity for someone to join the Architectural Control Committee. This is currently a group of 12 nice folks who volunteer to periodically walk an assigned area and help our homeowners by sending a reminder of repairs needed. We strive to keep our neighborhood looking its best. Alas, we should be a committee of 13. Please give me a call - we need one more volunteer.
