## **Committee Reports**

**Website** – No updates

Special Events - Cindy Kiel and Barbara Stokes will review and update the resident welcome packet.

**Clubhouse** -The Clubhouse remains closed. Barbara Stokes and Kathleen Sutton continue to work on new Clubhouse furnishings. An electrician will install recessed lighting fixtures and exterior dusk-to-dawn fixtures. Charlie Byrns will paint the ceiling and the walls of the clubhouse. Molly Stevens who is associated with Home Depot, will receive a check by the end of the year for her work with Kathleen Sutton to obtain warranty credit toward cost of replacement of the window blinds for the clubhouse.

**Pool** – The Board has requested a bid from Perfect Pools and three other companies to replace pool boiler and sand filters. The bids are due to the Board by November 16, 2020.

**Tennis Courts** – No updates.

Architectural Control Committee – Tavern Taupe will be eliminated as a trim paint color for the units.

**Newsletter** – Cindy Kiel wrote an article about energy savings for the December newsletter and an article on water conservation as requested by a homeowner for the November issue.

*Treasurer's Report* – Joe Johnston reported the Reserve account and the Paint Reserve balances on November 2, 2020.

**Grounds -** Lighting maintenance, sprinkler checks, repairs and the system shut off were completed in October. The following items are planned for November 2020: Leaf clean-up, caulk joints in swimming pool deck, snow removal, improvements to front bed areas and other general maintenance.

DRC Construction has confirmed their plans to complete the sewer line inspections by November 26, 2020.

A-1 Concrete Leveling completed sidewalk leveling at 7350-52 S. Knolls Way and has continued with leveling of sidewalk sections at buildings 7341-49 and 7351-69 S. Knolls Way.

A tree in the common area near 2574 E. Geddes Pl. is in danger of falling and has become a safety hazard. A motion to approve the removal of the tree was made by Joe Johnston and approved by Barbara Stokes. The motion passed.

The painting of the community's concrete sidewalk steps is nearing completion and weather permitting the student painters will paint mailbox bases and apply non-skid coatings to wooden bridges.
