April 2023 Board Meeting Minutes

## Maintenance Report

**DGO** Access has submitted a bid to change the bracing of the pool gate to reduce movement from frost heave. Warren feels another bid for this work is needed before making a decision on a more permanent repair.

Landscaping projects will continue this spring. **Cox professional Landscape Services** has submitted a bid for rock work associated with the zone replacement project. **Aqua Corp.**, who is the irrigation contractor, will provide a bid to the Board when the sprinklers are turned on in the community. At that point, the Board will vote on the bids from the two mentioned contractors for the future landscape projects.

After discussing whether a tennis court renovation should take place this year, it was decided that more information is needed. Warren will provide the Board with information concerning types of resurfacing materials, estimated life, crack resistance, cost, etc. at a later date.

The opening of the Knolls Village community pool is of paramount importance. Warren continues to work with **AquaWorks** in an attempt to expedite the process of the installation of the new heating equipment. He mentioned that there is some issue with guidelines to installation and permitting by the City of Centennial. The Board agrees that this is a very important amenity to the residents. Anne Krause will ask Todd and Warren to work together in furthering the process with **AquaWorks**.

South University Blvd fence repairs will continue.

The meeting was adjourned at 8:57 PM.
