Board Elections and Annual Homeowner's Meeting Tuesday, October 10th - 7:30 PM - Clubhouse

There will be elections to the Board at the Annual Homeowner's Meeting. The Board consists of 7 members (or directors). Currently, board members are Todd Mata, Anne Krause, Scott Ward, Darcy Johnson, Anne Waite, and AJ Quick. We are looking for 3 new board members. Terms for Todd Mata and Anne Krause are ending, and there is a remaining vacancy never filled from last winter.

Margie Nowick and Phil Andrews are running for positions on the Board, and their names will be on the ballot.

The way for you to directly vote in the election is to attend the October 10th meeting.

When you vote as a homeowner, you are voting for a board member (or director). Once the new board is formed, it is the board members who select the officers. This means, it is the board members who select, among themselves, the President, Vice President, Treasurer, and Secretary. Only homeowners vote in the election (and there is one vote per household). Only homeowners run in the election (no renters).

What is the Proxy Option? If you cannot attend the October 10th meeting, you may fill out a Proxy Form. A proxy is a homeowner who you know and who you choose to cast a vote on your behalf. Your proxy must attend the meeting.

In mid-September, you will receive a letter in the mail with information on the annual meeting, including the bios of the candidates. There will be a Proxy Form in this mailing that you fill out and return via the black box.

If you are interested in being on the Board, please contact us at board@knollsvillage.com or 303-796-0540. **We are still in need of another member.** There will be the opportunity to make nominations from the floor at the October 10th meeting.

Again, the proxy form is not your vote, but it is the name of a homeowner who you know will attend the meeting on October 10th and who will vote on your behalf. On the Knolls Village website, you may read the By-Laws as Amended, that outline the nominating and election process.
