
October 8th KVTA Election and Fast Progress of New KVTA Board

Architectural Control Committee Covenant Corner – A few things for your consideration this month.... Did you know??

*Halloween Decorations must be taken down in a timely manner, but no later than November 15th.

*Window Air Conditioners & Fans must be removed by October 15^{th.} If you haven't already removed them, please do so now.

Window Well Covers: Window Well Covers are not required in the KVTA bylaws; however, we strongly recommend that you cover all your window wells for safety and aesthetic reasons. Left uncovered, someone could fall and injure themselves or break into your basement. We have also seen cases where small animals have fallen into wells and die. The KVTA Replacement Requirement is for flat clear covers. Plastic flat covers can be found in local stores such as Home Depot (16" Americana SKU 1002-896-341, as an example), other home and hardware stores. More permanent custom flat covers can be found at several local companies such as Colorado Covers. **Bubble covers do not meet this standard.**

RECYCLING TIPS Size Matters in your Recycling Bin!

Did you know there's a minimum size for recyclable materials? We have a single-stream system, meaning recyclables all go in your recycling bin together. When that mix gets to the recycling center, it's their task to sort the materials into their respective categories—aluminum, steel, paper, plastic, glass, etc. This is tricky—especially with glass, which is smashed into tiny pieces and sorted out before the rest of the materials are hand-sorted. The mix containing the broken glass is passed over a two-inch gap in the conveyor belt, which serves as a screen to help separate the glass from anything larger than two inches. The tiny glass pieces fall through the gap, and everything else that's larger than two inches, like aluminum cans and plastic jugs, passes over the gap to continue through the system for further sorting.

That gap works really well for separating out the glass, but contamination problems can occur when similarly small items besides glass pieces fall through the screen. **If you put anything smaller than two inches into the recycling bin, like a loose plastic soda cap or a small scrap of paper, it will also fall through that gap and contaminate the glass stream.** So, before you recycle something, just make sure it's at least two inches wide, and your item will pass nicely over that "gap" in the facility!
