PARKING RULES AND REGULATIONS
pertaining to vehicle parking and restrictions thereto
on Knolls Village Townhouse Association, Inc. (KVTA)
owned property, i.e., driveways, KVTA owned streets,
and all perpendicular parking spaces (commonly
referred to as guest parking spaces).

- 1. Long term storage of vehicles, i.e., 14 days or more without being used, is prohibited.
- Storage of equipment, i.e., any non-vehicle occupying a parking space(s), e.g., dumpster, trailer, storage unit, etc., is prohibited at all times unless granted written permission by the Board for a designated period of time.
- Vehicles observed as inoperable, e.g., wrecked, flat or missing tires, etc., are prohibited as adopted by this resolution.
- 4. Boats, trailers, trucks, campers or commercial vehicles are prohibited as per Article X of the Association's Covenants. As adopted by this resolution, recreation vehicles (RVs) are prohibited from overnight parking on KVTA property.
- 5. Vehicles blocking, impeding or in any way preventing access to other parking spaces or garages are prohibited and shall constitute an emergency for towing purposes.
- The parking of any vehicle or equipment that blocks or limits access by fire or other emergency vehicles on the Knolls Village Townhouse Association roads is expressly prohibited and shall constitute an emergency for towing purposes.

Architectural Control Committee Covenant Corner – A few things for your consideration this month.

The Knolls Village is a Covenant Controlled Community. When you purchased your Townhome, or signed your rental agreement, you were provided with a copy of the Covenants and the Homeowners' Maintenance and Replacement Guide which provides a very practical guide for living in our community. Each homeowner is responsible for complying with the KVTA Covenants and the Board of Directors' policies and requirements including those of the Architectural Control Committee (ACC) regardless of whether they are aware of the requirements or not. The pertinent documents are at our Website: *KnollsVillage.com* and should be used as your reference for general information and for any changes you are considering to your townhome.

The Architectural Control Committee (ACC) has two processes in place to work with homeowners to ensure covenant compliance.

- 1. ACC Application Form & Approval Process: ALL changes to the outside of your unit, including but not limited to doors, windows, lighting, landscaping, roofs, Radon Mitigation, gates, and satellite dishes must be approved by the Architectural Control Committee BEFORE you order materials or begin work. To obtain prior written approval, please fill out an ACC Application Form and return it for processing as directed on the form. Application Forms are available online (www.knollsvillage.com) or at the Bulletin Board by the Clubhouse. You can generally expect a response within 5 to 7 days. As a reminder, work done without approval may have to be redone or removed if it does not comply with KVTA Covenants and Guidelines.
- 2. ACC Compliance Process: The ACC is charged with walking our community to determine if there are any issues that need addressing by homeowners to keep our community in compliance with our covenants. The ACC also sends (continued)

Advisory Letters for issues of safety or concern such as missing window well covers, rabbits under porches, that you may want to address. If you receive an Out of Compliance Letter, it will state the issue, corrective steps, and ask that you respond or resolve the issue within 30 days. If the ACC Chairperson does not hear from you and the issue is not resolved, the ACC will follow up with you to be sure the issue is resolved. When necessary, unresolved issues will be referred to the Board for follow-up.
